2025 NEIGHBORHOOD ASSISTANCE ACT (NAA) - PROGRAM PARTICIPATION

WHEREAS, the State of Connecticut Department of Revenue Services is providing the Town of Portland the opportunity to participate in the 2025 Neighborhood Assistance Act, thus allowing interested non-profit organizations within the municipality to submit applications; and

WHEREAS, in accordance with the State of Connecticut Department of Revenue Services, the Board of Selectmen shall hold a public hearing on all programs and the governing body of the municipality must vote to approve these programs; now therefore be it

John Dillon reported on the last BOE meeting, highlighting the Gildersleeve Lego Robotics event. The sprint sports program has started, and the recent play was a huge success. This

year's prom will be at the Glastonbury Hills Country Club. Dr. Britton reported on the budget process and thanked the department heads for their input.

Jim Tripp gave the Water & Sewer report. Negotiations took place with MDC and went as expected. East Hampton shares our interest in what we are doing with the water. He was pleased to see that the Parks & Rec pillars that were previously discussed in a BOS meeting were being replaced. John Dillon said he observed the work and it looks like they did something to hold them off the pavement. Jim Tripp said the six remaining ones will have to be replaced but they are not an urgent matter.
