FAIR HOUSING POLICY STATEMENT

It is both the policy and strong commitment of the Town of Portland to promote fair housing opportunities in all its programs and housing development activities and to take affirmative action through education and implementation of policies which ensure equal housing opportunities for all persons and families.

The Town of Portland will take affirmative action to ensure that all tenants, applicants, and residents are treated fairly without regard to their race, color, religion, age, sex, marital status, sexual orientation, national origin, ancestry, political beliefs, mental disabilities, learning disabilities, physical disabilities (including blindness), lawful source of income, or because the individual has children.

The Town of Portland will continue to make a good faith effort to comply with all federal and state laws and policies which speak to fair housing practices.

It is the policy of the Town of Portland that all housing-related personnel be trained and educated in the principles of fair housing and equal opportunity so that equal housing opportunity may be available to all qualified applicants.

This Fair Housing Policy Statement reaffirms our commitment to the principles of fair housing and equal opportunity housing practices.

The Fair Housing Officer, First Selectman Michael Pelton, or his designated representative is responsible for the implementation of the Fair Housing Policy Statement and the enforcement of this policy. The Fair Housing Officer may be reached at 860-342-6715.

Complaints pertaining to discrimination in any program funded by the Town of Portland may be filed with the Fair Housing Officer. The Town's Grievance Procedure will be utilized in these cases.

FAIR HOUSING MONTH

- **WHEREAS,** April 2025 marks the 57th Anniversary of Title VIII of the Civil Rights Act of 1968, known as the Civil Rights Fair Housing Act; and
- **WHEREAS**, this Act provides equal housing opportunity for all Americans regardless of race, color, religion, sex or national origin, as well as to ensure fair practice in the sale, rental or financing of property; and
- **WHEREAS**, the Fair Housing Amendments Act of 1988 added new rights, remedies, monetary penalties, and strengthened its enforcement procedures; and
- **WHEREAS,** the Fair Housing Amendments Act seeks to provide equal housing opportunities, to affirmatively further housing choices, to eliminate legal barriers to equal housing and to emphasize equal housing as a fundamental human right for all; and
- **WHEREAS**, recipients of funds from the Town must carry out an affirmative marketing program to attract prospective buyers or tenants of all majority and minority groups, without

consideration of race, color, religion, sex, disability, age, gender identity, familial status or national origin; *and*

WHEREAS, the Town of Portland, Connecticut fully supports the intent and purpose of the Federal Fair Housing Act, local fair housing laws and follows policies and practices in order to achieve its goal.

NOW, THEREFORE, BE IT RESOLVED that I, Michael A. Pelton, First Selectman of the Town of Portland Connecticut, do hereby proclaim the month of **April 2025** as "**Fair Housing Month**."

9. STATUS & COMMITTEE REPORTS

Water & Sewer: Jim Tripp said they are still in a holding pattern. They are waiting for the flooding to subside to do the pumpdown test. The Coe Avenue situation is still on hold. Supposedly it is a materials issue. Something isn't adding up with the delay. They are trying to get a better answer. There were no major breaks in the last month. The MDC fiscal year runs from January 1 through December 31st. We try to get the required gallons to satisfy them. In the spring, we run the well. It was noted that the well has been a little lighter and MDC a little more than normal.

Congratulations was expressed to Jim Lynch for his upcoming retirement and service in running the wastewater facility. Thanks were extended for his 30-some years of service.

Michael Pelton said there is to be a trash cleanup this Friday. The easement adjustment is to be signed off by Tilcon. They are waiting for Geoff Jacobson to come back with final plans. They are hoping to start construction on the river access project this summer.

- Regarding the Spa, Michael said the groundwork digging should be starting soon. They have it locked up with Eversource. Construction time should take about 18 months.
- A project group is working on plans for a Farmers Market. The location has not yet been identified.
- The grand opening for Starbucks will take place on April 29 from 3-5 with the ribbon cutting taking place at 4:00 p.m. An invitation was extended to BOS members.
- We may have the river access completed by the end of the year.
- Charging Stations for the Town: It is time for another discussion on this. Agenda item for next meeting. Where would they be located? Is there a requirement for them at Brainerd Place?
- Attended Firemen's Banquet: Awards given to firefighters based on their time. Also honored Shaun Manning with a commemorative coin.
- Was interviewed re things of Portland. Portland is the golf capital of CT. We have eight miles of river coast.
- Ruth Maio will be honored on April 27 at St. Mary's Church.
- Hasn't heard "noise" about the budget. Should be in *Rivereast* this week. Michael encouraged BOS to get the word out about the budget. John suggested giving the public the link, the date and time. Michael wants to do a video explaining the budget and get it out there soon. He received no questions re the change in car tax.

11. BOARD OF SELECTMEN GENERAL INFORMAL DISCUSSION

Robert Hetrick asked about the food recycling project at the transfer station. We are paying three times the rate that we pay for bulky waste. Does it make sense to continue this project?

Hetrick also brought up the horrible condition of the high school parking lot. We need to preserve the parking lot as long as we can. Maybe take care of the cracks this year and then seal it next year. We can't continue to push it down the road. Who pays for it: BOE or us?

A brief discussion ensued regarding the condition of the sidewalk at the end of Waverly Avenue Ext. There are sidewalks on both sides of the street. The sidewalk on one side is unwalkable. Determine what side Public Works wants the sidewalk on. There is also a bus stop on that street. Also, there is a big tree on Highland that needs to be taken down.

Chris Cote offered to manicure the area where the "Welcome" sign used to be. John Dillon thinks maybe we could ask other businesses to take responsibility for some other opportunities for improvement in the town.

Rick Sharr said there is some work that needs to be done on the Air Line Trail, such as knocking down some of the brush.

Regarding the town charter, Michael suggests each BOS member should mark their copy up with their suggestions, and then it will be an agenda item for the first meeting in June.
