The application must be completed in full, approved locally, and submitted to the Department of Revenue Services (DRS) no later than **July 1, 2022**. Note this deadline is set by statute.

A fillable Form NAA-01, 2022 Connecticut Neighborhood Assistance Act (NAA) Program Proposal, is available on the DRS website at portal.ct.gov/DRS. Using the fillable Form NAA-01 enables you and your community organization to input information directly onto the form via computer.

Prior to your July 1 submission to DRS, your municipality must hold a public hearing on all programs, and the governing body of your municipality must vote to approve these programs. Copies of the public hearing notice and minutes of the meeting approving the programs must be submitted electronically with your applications.

Due to the ongoing pandemic, NAA submissions will not be accepted on paper. Contact DRS by email at **NAAProgram@ct.gov** to receive instructions on how to process your submission through our MOVEit Secure File Transfer System.

Note that the total amount of credits is limited each year, so credits may be prorated.

Please designate a liaison to handle all Neighborhood Assistance Act matters. You must enter the name, address, email address, telephone number, and fax number of your liaison in Part IV of the application. **DRS will directly notify your liaison by email of the programs that have been approved.** You must notify your participating organizations accordingly as DRS will not contact them directly.

Lastly, be reminded that any organization receiving \$25,000 or more in contributions is required to submit a post-project audit to the town. The audit should be conducted by a certified public accountant (CPA). All audits received by the town should be forwarded to DRS, again through our MOVEit system.





Town of Portland ADA Grievance Procedure

This Grievance Procedure is established to meet the requirements of the Americans with Disabilities Act. It may be used by anyone who wishes to file a complaint alleging discrimination on the basis of disability in employment practices and policies or the provision of services, activities, programs, or benefits by the Town of Portland.

The complaint should be in writing and contain information about the alleged discrimination such as name, address, phone number of complainant and location, date, and description of the problem. Alternative means of filing complaints, such as personal interviews or a tape recording of the complaint will be made available for persons with disabilities upon request.

The complaint should be submitted by the grievant and/or his/designee as soon as possible but no later 60 calendar days after the allege violation to:

Within 15 calendar days after receipt of the complaint, Peter Willse will meet with the complainant to discuss the complaint and possible resolutions.

Within 15 calendar days after the meeting, Peter Willse will respond in writing, and, where appropriate, in a format accessible to the complainant, such as large print, Braille, or audio tape. The response will explain the position of the Town of Portland and offer options for substantive resolution of the complaint.

Within 15 calendar days after receipt of the response, if the response by Peter Willse does not satisfactorily resolve the issue, the grievant and/or his/her designee may appeal the decision of the ADA Coordinator to the First Selectman or her designee.

Within 15 calendar days after receipt of the appeal, the <u>First Selectman</u> or his/her designee will respond in writing, and where appropriate, in a format accessible to the grievant, with a final resolution of the complaint.

All written grievance received by the Town of Portland, appeals to the <u>First Selectman</u> or his or her designee, and responses from the ADA Coordinator and <u>First Selectman</u> or his or her designee will be kept by the Town of Portland for at least three years.

SUPPLEMENTAL APPROPRIATION SYSTEM WIDE BOE – TECHNOLOGY UPGRADES AND INCREASE TO FEDERAL GRANTS

WHEREAS, the Board of Education (the "BOE") has been awarded a Federal Communications Commission Emergency Connectivity Fund Program (CFDA 32.009) grant in the amount of \$169,480. The initial purchase of chromebooks was funded by capital lease proceeds. Based on the lease schedule approximately \$150,000 of principal will be paid back by September 1, 2022; and

WHEREAS, the funds should be used for similar chromebook purchases or other hardware technology; and

WHEREAS, the BOE has been awarded another grant from E-Rate that will directly provide to the BOE 370 chromebooks at roughly \$77,150. E-Rate will directly pay the vendor for the devices. The BOE will be responsible for licensing, warranty, carrying cases and accessories related to the devices; and

WHEREAS, the BOE requests to use a portion of the \$169,480 to cover these related chromebook charges for licensing, warranty, carrying cases and accessories. The remainder of the funds will be used for technology hardware such as, but not limited to, smartboards, projectors, laptops, desktop computers and printers.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Selectmen hereby approves an increase in estimated revenue #08-141-000-00114 of federal grants and a supplemental appropriation in the amount of \$169,480 in line item #08-141-000-89010 – Board of Education – System Wide BOE – Technology Upgrades.

NOTE: pursuant to Section 1203.4 of the Portland Town Charter this requires a public hearing prior to BOS approval, and pursuant to Section 503(g) is subject to approval at a Special Town Meeting
